

**NOTICE TO CANDIDATES**

Each candidate shall sign his notice of candidacy at the office of the Pender County Board of Elections in the presence of any member or the Director of the Board of Elections. In the alternative, a candidate may have his signature on the Notice of Candidacy acknowledged and certified to by an officer authorized to take acknowledgements and administer oaths, in which case the candidate may mail or deliver his Notice of Candidacy to the Pender County Board of Elections, P.O. Box 1232, Burgaw, NC 28425. A Notice of Candidacy shall be deemed to have been filed with the Board of Elections when it is received by that Board.

The candidate shall sign the Notice of Candidacy with his legal name and, in his discretion, any nickname by which he is commonly known, in the form that he wishes it to appear upon the ballot but substantially as follows: 'Richard D. (Dick) Roe'.

The Notice of Candidacy must be in the possession of the Pender County Board of Elections by 12 o'clock noon on the first Friday in July preceding the election. The candidate shall pay a filing fee of five dollars (\$5.00) at the time he files the Notice of Candidacy.

A Notice of Candidacy signed by an agent or any other person other than the candidate himself shall be invalid.
