

WHEREAS, A. D. (Zander) Guy, II, at the September, 1990, Term of the Superior Court of Onslow County, was convicted of Obtaining Property by False Pretense, seven (7) counts, and was sentenced to a term of three (3) years in the custody of the Department of Correction. At the same term of Court he was also convicted of Obtaining Property by False Pretense, five (5) counts, and was sentenced to a term of seven (7) years at expiration, suspended with five (5) years probation.

WHEREAS, Mr. Guy now seeks, in light of the circumstances surrounding his crimes and his subsequent record, forgiveness by the State.

WHEREAS, Mr. Guy's record, since his conviction, has been one of responsible civic behavior and community service;

NOW, THEREFORE, I, James G. Martin, Governor of the State of North Carolina, in consideration of the above factors, and by virtue of the power and authority vested in me by the Constitution of the State do hereby present PARDON the said A. D. (Zander)
