Background: We have over the past few years started to see an increase in gang activity in Pender County. In an effort to keep track of the activity and stop additional gangs and gang related crime, the Pender County Sheriff's Office has joined a regional task force with New Hanover and Brunswick Counties. New Hanover County has recently reformed their Gang Task Force and received grant funding for gang identification and intervention. The grant received by New Hanover County is contingent on a small matching fund from Brunswick and Pender. Pender's share is \$6,250. This is the second year of the grant. The grant pays for counselors and programs that identify and redirect gang member activities. This item was included in the FY 07-08 budget. The funds will come from the Sheriff's Drug Seizure Account.
