**Short Title:** Public Hearing To Rename And Readdress The North End Of St. Johns Church Road.

**Background:** St. Johns Church Road was addressed when Pender County adopted the Emergency 911 System in the early 1990's. Jenkins Road is the stub street that connects the two segments of St. Johns Church Road. This is a T intersection and should have been addressed as such. Unfortunately, the consultants began numbering at Jenkins Road and continued down the southernmost segment of St. Johns Church Road. The northernmost segment was addressed beginning at 577 and ending at 481.

The current addressing scheme is not conducive to a swift and efficient response. The numbers decrease in range instead of increasing as you are traveling north on St. Johns Church Road.

With the construction of the new Topsail High School it is my opinion that in order to have consistent numbering it is necessary to readdress the northernmost segment beginning at the T intersection and ending at the new school. It is also necessary to place a directional on the two segments of St. Johns Church Road.

Under the authority and provision of the General Statutes of North Carolina, Chapter 153A-239.1, a county may by ordinance reassign street numbers. The statute requires that a public hearing be held on the matter. According to Article I, Section 103 of the Pender County Property Addressing and Display Ordinance, as conditions merit, such official numbers may be changed upon proper official notice to the property owner and public agencies.

The Legal Notices have been properly posted and the residents have been notified.

**Specific Action Requested:** The Board is requested to hold a public hearing to determine if the County should rename and readdress the northernmost end of St. Johns Church Road.
