Background: Pender County Schools applied for and received a Safe Schools/Healthy Students Grant that included the formation of a County Gang Resistance Unit through the Pender County Sheriff's Office. This unit will be made up of three (3) sworn law enforcement officers and one (1) case worker. The law enforcement officers will be employees of the Sheriff's Office while the case worker will be hired by the schools. The objectives of this Gang Resistance Unit will be to monitor, respond to, and combat gang activity in the schools and county with a large emphasis on training and education. The two deputies will implement the GREAT (Gang Resistance Education And Training) program which, because it teaches life skills and does contain information on the hazards of illegal drugs, will replace the DARE training currently taught in the schools. Grant funds will be used to fund the salaries of these three new positions and the grant period is for 4 years. Operating expenses will come from the existing Sheriff's Office budget.
