SHORT TITLE: Resolution Authorizing Purchase Orders to Garvey Flooring, Inc., in the amount of \$8,481.30 for Classroom Tile Flooring and to Farrior's Flooring and Interiors in the amount of \$9,592.27 for New Carpeting in the Auditorium, and Administrative Offices at Penderlea School

BACKGROUND: Of the \$56 million school bond referendum approved by voters on May 3, 2005, \$2,306,000 was originally allocated for renovations to Penderlea School. Pursuant to a budget ordinance amendment on September 19, 2007, this allocation was reduced by \$1,806,000 to \$500,000. Thus far the Board has authorized allocations totaling \$259,268.02 to this project.

At this time, the schools are requesting approval of the attached proposal from Garvey Flooring, Inc., to replace tile in various classrooms. In addition they are requesting approval of a proposal from Farrior's Flooring & Interiors for new carpeting in the Auditorium and Administrative Offices.

The County and Schools have entered into the appropriate agreements to permit the County to pay the bills associated with this construction in order to recapture the sales taxes paid and realize a substantial savings.

SPECIFIC ACTION REQUESTED: The Board of Commissioner is requested to authorize the following contracts and purchase orders:
