SHORT TITLE: Resolution Authorizing a Scattered Site Application for CDBG-Recovery (CDBG-R) Funding from the Division of Community Assistance in the Amount of \$400,000

BACKGROUND: The County has submitted an application for \$400,000 in CDBG-R Funds to assist (5) LMI Households that are living in severely deteriorated housing. The applications were made available to cities and counties on June 1, and the deadline for submission was June 12, therefore staff was unable to attain formal Board approval prior to submitting the application. The County Manager authorized the application after conferring with Chairman Tate. This funding is part of the American Recovery and Reinvestment Act of 2009 (Stimulus Money).

SPECIFIC ACTION REQUESTED: To adopt a resolution approving the application for \$400,000 in CDBG-R funding in order to assist (5) LMI households in the county.


