SHORT TITLE: A Resolution Authorizing Pender County Department of Planning and Community Development to Issue Building Permits and Perform Inspections within the Town of Atkinson for FY 2009-2010.

BACKGROUND: The Board of Commissioners approved a request from the Town of Atkinson for FY 08/09 for the County to issue building permits and perform inspections within the Town limits. The Town was responsible for providing evidence of their zoning approval prior to County staff accepting building permits. The Town has requested this service be approved to continue for FY 09/10. The Town of Atkinson will continue to issue zoning approval to permit applicants prior to County staff accepting building permit applications. Building permit applicants within the Town will continue to be required to follow County Department of Planning and Community Development fees, policies and procedures.

SPECIFIC ACTION REQUESTED: To adopt a resolution authorizing the Department of Planning and Community Development to issue building permits and perform inspections within the Atkinson Town limits for FY 09/10.
