SHORT TITLE: Resolution to approve a Purchase Order and Contract to Port City Builders for the Dental Clinic Relocation: \$73,397.

BACKGROUND: In FY 2009, the Board approved an ordinance to increase the Health Department's budget and expenditures in the amount of 75K from the Cape Fear Memorial Foundation to renovate space in the Health Department building and relocate the Dental Clinic.

The Health Department building renovation and Dental Clinic relocation was re-advertised on July 29, 2006 and bid opening was held August 11, 2009, with five bidders submitting. (Bid sheet attached)

SPECIFIC ACTION REQUESTED: The board is requested to authorize a purchase order and contract for to Port City Builders, Inc in the amount of \$73,397 for Fiscal Year 2009-2010.
