**DATE OF MEETING:** May 3, 2010

**REQUESTED BY:** Pender County Schools

**SHORT TITLE:** Resolution Authorizing a Purchase Order to Quality Turf, Inc., in the Amount of \$6,750 for Landscaping at Topsail High School

**BACKGROUND:** In order to complete the new construction project at Topsail High School, the schools are requesting approval of a purchase order to Quality Turf, Inc., in the amount of \$6,750 for the purchase of 600 Bushels of Celebration Sprigs Planted over 7.5 acres at this campus. The cost is \$900 per acre.

The County and Schools have entered into the appropriate agreements to permit the County to pay the bills associated with this construction in order to recapture the sales taxes paid and realize a substantial savings.

**SPECIFIC ACTION REQUESTED:** To consider a resolution to authorize a purchase order to Quality Turf, Inc., in the amount of \$6,750 landscaping 7.5 acres.
