**REQUESTED BY:** Dee Turner, Chairperson of Pender County JCPC

**SHORT TITLE:** Resolution to Approve FY 11-12 Unallocated Juvenile Crime Prevention Council Funds to Coastal Horizons: \$11,359

**BACKGROUND:** The Juvenile Crime Prevention Council (JCPC) is a state mandated county board tasked with overseeing the distribution of state funds for programs serving youth who are currently in the juvenile justice system or are at-risk of entering it. The Department of Juvenile Justice and Delinquency Prevention (DJJDP) indicated that there may be up to a 10% reduction in the amount of money that would be received for FY 2011-2012. Therefore, the Pender County JCPC based funding recommendations on a 10% reduction which calculates to \$102,232 for FY 11-12 when presented to the Board of County Commissioners on May 2, 2011. However, Pender County did not receive a reduction in funding so \$11,359 is available for program services. Coastal Horizons has revised a previously submitted program agreement to include three components; 1) small group therapy which will address anger management; 2) out-patient family counseling which will address behavior issues and parenting skills; 3) small group therapy which will address substance abuse using the Seven Challenge Model. These services will be offered for the remainder of FY 2011-2012 using JCPC funds of \$11,359 and other funds provided by Coastal Horizons.

**SPECIFIC ACTION REQUESTED:** To consider a resolution approving FY 11-12 unallocated Juvenile Crime Prevention Council funds to Coastal Horizons in the amount of \$11,359
