**SHORT TITLE:** Resolution to Consider Approving Appointment to the Pender County Board of Adjustment

**BACKGROUND:** The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role. Commissioners are welcome to recruit applicants, or citizens may apply of their own free will.

**SPECIFIC ACTION REQUESTED:** The Board is requested to consider a resolution approving appointment to the Pender County Board of Adjustment.

**COUNTY MANAGER'S RECOMMENDATION:**

All appointment authority rests with the Board of Commissioners.

**RESOLUTION**

**NOW THEREFORE BE IT RESOLVED** by the Pender County Board of Commissioners that the following appointment is made:

**Board of Adjustment: (1 appointment)**

The Board of Adjustment is created by State statute and its purpose is to hear appeals from decision of the Planning Department and to consider requests for variances from the terms of the UDO. The Board meets the 3<sup>rd</sup> Wednesday of every month at 9:00 a.m., unless there are no cases to hear. The Board is comprised of seven Board of Commissioners appointments which consist of one citizen from each Commissioner District and two alternates. The terms are for three years. The County funds the Planning Department.

**Note:** The applicant, Mr. Erwin Kane, is presently a member of the Board of Adjustment and wishes to be reappointed. Mr. Kane has served two three-year terms on the Board of Adjustment, and is qualified to serve another term under the Board's ten-year rule.


