SHORT TITLE: Resolution to Consider Approving Appointment to the Pender County Planning Board

BACKGROUND: The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role. Commissioners are welcome to recruit applicants, or citizens may apply of their own free will.

SPECIFIC ACTION REQUESTED: The Board is requested to consider a resolution approving appointment to the Pender County Planning Board.

COUNTY MANAGER'S RECOMMENDATION:

All appointment authority rests with the Board of Commissioners.

NOW THEREFORE BE IT RESOLVED by the Pender County Board of Commissioners that the following appointments are made:

Planning Board (2 Appointments-5 Applicants)

The Planning Board is created by State statute and its purpose is to carry out the land use planning activities and setting zoning policy and regulation in Pender County. The Board is comprised of seven Board of Commissioners appointments in the following categories: one AG/Environmental, one Business, one Environmental, one Professional, one Technical and two At-Large. Two Commissioners also act as Alternates. The Board meets the 1st Tuesday of every month at 7:00 p.m. The terms are for three years. The County funds the Planning Department.

Note: The applicants are: Walter Baker, Malcolm Boney, Sue LoRusso, Bill Marshburn and Jeremy Strong. Mr. Boney and Mr. Marshburn are currently members of the Planning Board whose terms will expire soon, and they wish to be reappointed. Mr. Boney has served one three-year term on the Planning Board as a representative in the Professional position, and Mr. Marshburn two three-year terms in an At-Large position. Both are qualified to serve another term under the Board's ten-year rule. Mr. Baker, Ms. LoRusso and Mr. Strong are new applicants.



Mr. Baker has over 38 years of experience with General Electric Co, Brown Engineering - a Teledyne Company and North American Aviation Rockwell. On retiring from industry, Mr. Baker established and is president of *QUALITY ARTS, INC.*¹ providing consulting on methods for management of quality products and services. Mr. Baker has experience in quality assurance, project management, and design engineering in the nuclear and aerospace industries. He has managed internal audits of the design and manufacture of nuclear fuel and components, and Quality measurements of compliance with the Nuclear Regulatory Commission, American Society of Mechanical Engineers and business requirements. He performed evaluations and was a contributor in the writing of the initial Quality Assurance Program for the National Aeronautics and Space Administration (NASA) Space Shuttle Program. He has managed design integration, design reviews, and configuration control activities for the NASA Apollo (lunar landing) program. Mr. Baker also performed development and testing of Air Force missile systems.

Mr. Baker is a charter member of the American Society for Quality, Quality Audit Division. He has held a Certification from the Registrar Accreditation Board as a Quality System Lead Auditor. He has written and presented papers including - PERFORMANCE BASED AUDITS FOR MULTICUSTOMERS, EFFECTIVE CORRECTION ACTION, AUDITING THE HOTEL FROM PUZZLE TO PRACTICE, DISCOVERING NEW FRONTIERS IN THE AUDITING PROFESSION.

Mr. Baker has been active in civic affairs. Community activities have included; conducting a review of Police Department Policies and Procedures with recommendations for revising to reflect the organization and responsibilities, chairing a Charter Commission, which prepared a Charter for consolidation of the City and the County. He has served for two terms on a City Planning Commission. Mr. Baker was active in the Houston, Texas community, holding several civic offices, including President of a local Civic Club and serving on the Greater Houston Civic Club Council. 
