SHORT TITLE: Resolution to Consider Approving Appointments to the Pender County Board of Health and the Pender County Planning Board

BACKGROUND: The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role. Commissioners are welcome to recruit applicants, or citizens may apply of their own free will.

SPECIFIC ACTION REQUESTED: The Board is requested to consider a resolution approving appointment to the Pender County Board of Health and Pender County Planning Board.

COUNTY MANAGER'S RECOMMENDATION:

All appointment authority rests with the Board of Commissioners.

RESOLUTION

NOW THEREFORE BE IT RESOLVED by the Pender County Board of Commissioners that the following appointments are made:

Board of Health:
Physician (1 Vacancy-1 Applicant)
Public Member (1 Vacancy-4 Applicants)

The Health Board is created by State statute and it is the policy-making, rule-making and adjudicatory body for the Pender County Health Department. The Board meets the 3rd Tuesday of every other month at 7:00 p.m. The Board is comprised of eleven Board of Commissioners appointments which consist of: one commissioner, one dentist, one engineer, one nurse, one optometrist, one pharmacist, one physician, one veterinarian, and three public members. The terms are for three years. The County funds approximately 43% of the Health Department budget.

Note: Ms. Baker is not a physician but the Board of Health bylaws state if there is not a licensed physician available for appointment, a representative of the general public may be appointed.

The Planning Board is created by State statute and its purpose is to carry out the land use planning activities and setting zoning policy and regulation in Pender County. The Board is comprised of seven Board of Commissioners appointments in the following categories: one AG/Environmental, one Business, one Environmental, one Professional, one Technical and two At-Large. Two Commissioners also act as Alternates. The Board meets the 1st Tuesday of every month at 7:00 p.m. The terms are for three years. The County funds the Planning Department.


