SHORT TITLE: Resolution Authorizing Approval of Purchase Order for Health Department Medical Professional Liability Renewal for Fiscal Year 2012-2013: \$9,675.12

BACKGROUND: The health department provides basic outpatient primary health care and must carry malpractice insurance. The limits of liability with this insurance are \$1 million dollars per person with a \$3 million dollar total limit on the shared limited basis. The coverage includes claims made by patients for miscellaneous liability. The Snowden Company, LLC is the group insurance provider for the NC Association of Local Health Departments through the Association of NC County Commissioners. Pender County Health Department has an excellent history with no claims reported.

SPECIFIC ACTION REQUESTED: To consider a resolution authorizing purchase order for The Snowden Company, LLC in the amount of \$9,675.12 for Fiscal Year 2012-2013.
