ADDITIONAL INFORMATION AND SUPPORT OF INTREST

Pender County is a wonderful place for visitors. It offers miles of ocean front beaches along with many other outdoor and culture experiences for all who visit. We need to create interest for a few accommodations to be built both on Highway 17 and Highway 421 for those who would like to visit for a shorter period of time. The beach accommodations require a weekly rental period which stymies regional visitors who may want to come for two day get-ways or events (Ft. Bragg/Camp Lejeune). This would attract regional sporting events or other activities such as soccer, tennis, running, fishing, hunting, horse shows, tractor pulls, and historic reenactments craft fairs and family reunions to mention just a few events.

Tourism is the promoting arm of the County Government and one of its economic development arms. Attracting such activities that I have mentioned with the additional accommodations brings to the County not only the room occupancy Tax revenues but 2.5% of additional revenue spent within in the local economy.
