REQUESTED BY: Kyle Breuer, Director, Planning and Community Development Department

SHORT TITLE: Resolution Approving Appointment of Steering Committee for Maple Hill Small Area Plan.

BACKGROUND: At the January 7, 2013 Board meeting, Staff presented plans to the Board to move forward in developing a Small Area Plan for the Maple Hill area. Staff held a Public Kickoff Meeting for the project on January 26, 2013 to inform area citizens and stakeholders of the project and distribute applications to solicit participation in the Steering Committee. The Kickoff Meeting had approximately twenty attendees which provided valuable input for Staff to begin drafting a vision statement for the plan. It is anticipated that the Steering Committee will meet monthly or approximately five times throughout the planning process.

SPECIFIC ACTION REQUESTED: Planning Staff is requesting the appointment of the Maple Hill Small Area Plan Steering Committee based off of the applications received along with a representative from the Planning Board and Board of Commissioners. The Committee will meet regularly during the development of the plan to provide representation for project stakeholders as well as provide input and direction to Planning Staff for the development of the Plan.






