REQUESTED BY: Mickey Duvall, County Manager

SHORT TITLE: Resolution Establishing a Pender County Animal Shelter Advisory Committee and Approving Appointments to the Committee.

BACKGROUND: The Board of Commissioners indicated they would like an Animal Shelter Advisory Committee to assist with and advise the Board on Animal Shelter issues. The committee will consist of a Commissioner, the Health Director, a Veterinarian, a Citizen-Animal Rights Advocate; and a Citizen-At-Large. Mr. McCoy has volunteered to serve in the Commissioner position. The following is a listing of suggested terms: Health Director-Standing; Commissioner-3 Years; Veterinarian-3 Years; Animal Rights Advocate-2 Years; Citizen-At-Large: 2 Years.

The Animal Shelter Advisory Board openings were advertised for six consecutive weeks and the applications are attached. One application was received for the Veterinarian position: Audrey Mizrahi, DVM. Nine applications were received for the Citizen positions: Barbara Blandine, Forrest Casha, Dennis Connor, III, Sylvia Hall, Christie Halligan, Jewell Horton, Sue LeBright, Barbara Raab and Paul Rivenbark.
