**DATE OF MEETING:** August 5, 2013

**REQUESTED BY:** Pender County Republican Party Executive Committee

**SHORT TITLE:** Appointment Recommendation by the Pender County Republican Party Executive Committee to the Pender County Board of Commissioners to fill the unexpired term of the late Pender County Register of Deeds, Mrs. Faye Teachey Prevatte.

**BACKGROUND:** Pender County Register of Deeds, Mrs. Faye Teachey Prevatte passed away on July 4, 2013 after fighting a courageous battle with cancer. In accordance with the N.C. General Statutes, the Pender County Republican Party Executive Committee hereby recommends to the Pender County Board of Commissioners appointment of Ms. Sharon Blansett Willoughby to fill the unexpired term of Mrs. Prevatte. In a letter dated July 29, 2013 by Pender County Republican Party Chairman Mr. Robert "Bob" Muller on behalf of the Pender County Republican Party Executive Committee, it was emphasized that Ms. Willoughby currently serves as the Chief Assistant at the Pender County Register of Deeds Office and is well qualified for appointment to this position. Mr. Muller indicated that the Pender County Republican Party Executive Committee met on July 27, 2013 and following the Party Plan of Organization criteria for filling vacancies of elected officials under the NC General Statutes, duly selected Ms. Willoughby.
