**BACKGROUND:** N.C.G.S. 105-321 (b) requires the Governing Board to enter its minutes an order directing the Tax Collector to collect the taxes set forth in the tax records filed in the Office of the Pender County Tax Collector. This order shall be a full and sufficient authority to direct, require, and enable the Collector to levy on, sell real or personal property of such taxpayers, for and on account thereof, in accordance with law.

The Chairman and/or County Manager is authorized to execute any/all agreements necessary to implement resolutions.
