SHORT TITLE: Resolution Authorizing Approval of Appointment to the Pender County Board of Adjustment

BACKGROUND: The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role. Commissioners are welcome to recruit applicants, or citizens may apply of their own free will.

Mark Walton has served almost a year on the Pender County Board of Adjustment as a fill-in, representing District 3. The term expires January 4, 2015 and Mr. Walton wishes to be appointed to a full term. The position has been advertised and Mr. Walton is the only applicant.

Gregory Goble has applied to serve on the Board of Adjustment representing District 4, which is currently vacant. There were no other applicants for this position. Mr. Goble currently serves on the Parks and Recreation Board.
