SHORT TITLE: Resolution Authorizing Approval of Appointments to the Pender County Council on Community Affairs.

BACKGROUND: The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role.
