SHORT TITLE: Resolution Authorizing Approval of Appointment to the Pender County Fire Commission.

BACKGROUND: The County Manager/County Clerk advertises vacancies on boards, commissions, committees, task forces, etc. The County Manager/County Clerk serves only clearinghouse functions with respect to the appointment process; no influence is exerted in this role. Commissioners are welcome to recruit applicants, or citizens may apply of their own free will.

Chief Kristopher Tucker of the Rocky Point Fire Department is applying to serve on the Fire Commission Board for the first time. He is applying to replace Chief Josh Moss who is the former Fire Chief of the Rocky Point Fire Department. This appointment will be for three years.


