REQUESTED BY: Carolyn Moser, Health Director, Pender County Health Department

SHORT TITLE: Approval of a Budget Amendment to Increase in Health Department Revenues and Expenditures for Fiscal Year 2015-2016: Adult Health \$21,250.

BACKGROUND: The NC Medicaid EHR (Electronic Health Records) Incentive Program was created by the federal government as part of the American Recovery and Reinvestment Act. The program is to encourage eligible professionals to upgrade to a certified EHR and then to demonstrate meaningful use (MU). The first year's incentive payment is \$21,250 per provider, and additional payments for \$8,500 for up to 5 years.

The Health Department has met all of the requirements and the NC Medicaid EHR Incentive Program will provide payment in the amount of \$21,250 for one of the Providers that work in the clinic. The Health Department would like to accept the incentive payment from Medicaid.

SPECIFIC ACTION REQUESTED: To consider approving a budget amendment for increasing additional programmatic revenues (11-370003) and related expenditures (900076-404500) for Pender County Health Department by \$21,250, from the NC Medicaid EHR Incentive Program for Fiscal Year 2015-2016.
