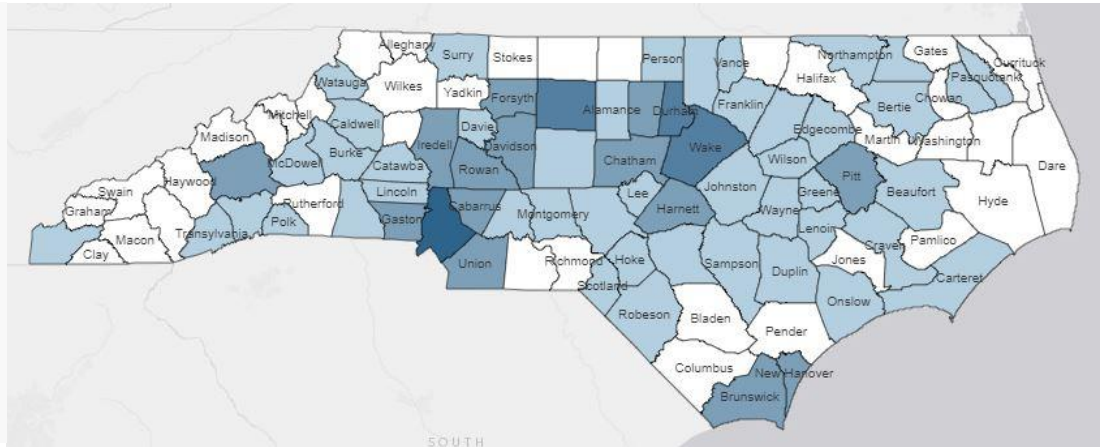
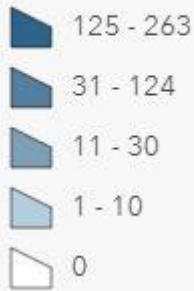
The County is currently operating at EOC Status Level 3.

7. Current Situation:			
<p>EOC IS OPERATING AT A LEVEL 3 STATUS: Level 3 is a hazard specific response to an incident. This incident requires the assistance of several State agencies. The Emergency Operations Center is activated but only staffed with essential personnel. The EOC is not operating on 24-hour shifts. The EOC is only functioning during standard business hours, with minimal weekend staffing.</p>			
<p>Weather: Today's Weather: Mostly sunny, with a high near 84. Southwest wind around 11 mph, with gusts as high as 17 mph Tonight: Partly cloudy, with a low around 64. Southwest wind around 10 mph. No hazardous weather is expected at this time.</p>			
<p>Fire Weather: RP-3: High pressure will be in control of conditions for the weekend. A mostly dry cold front will move across the area late Sunday followed by a stronger and more complex system Tuesday into Wednesday. High pressure will build in again late in the period. Wind profile analysis/fire control over flat terrain is Favorable. Fog potential for tonight is Low.</p>			
GOVERNOR COOPER EXECUTIVE ORDERS (EOs)			
<ul style="list-style-type: none"> • EO 117 (March 14, 2020): Limited mass gatherings to 100 persons and closed K-12 public schools. • EO 118 (March 17, 2020): Limited operations of restaurants/bars and broadened unemployment benefits. • EO 119 (March 21, 2020): Facilitated critical motor vehicle regulations, waived regulations to expand access to childcare, and support local health departments. • EO 120 (March 23, 2020): Reduced the mass gathering limit to 50 persons, extended public school closers until at least May 15, 2020, limited long term care visitations, closed entertainment and other service facilities, and provided direction to local governments regarding service delivery as well as employee safety. • EO 121 (March 27, 2020): Issued "stay-at-home" order to take effect at 5:00 PM Monday, March 30, 2020 for a period no less than thirty (30) days, established essential activities and essential businesses, reduced the mass gathering limit to 10 persons, and clarified local authority to establish greater restrictions in accordance with North Carolina law.

11. Incident Area: As of today (**3/28**), the Pender County Health Department is aware of a total of thirty-seven (37) COVID-19 tests completed within the County. This includes Pender Memorial Hospital, Pender County Health Department, and other healthcare providers. Of those tests, **twenty-three (23)** were confirmed negative, while **fourteen (14)** tests are currently pending. There have been no confirmed positive tests.

12. External Affairs: Pender County remains in monitoring mode. The Public Information Officer and the communications team are monitoring the County’s social media platforms and updating the County’s website with accurate information.

13. County Action:

- Pender County School System is feeding students and anyone 18 or younger at 62 sites around the county, with specific information [available here](#).
- Pender County Schools is providing wi-fi hotspots for school-issued devices from 7 AM to 7 PM seven days a week at Pender High, Topsail High, Heide Trask High, and **West Pender Middle**. There is also a public wi-fi access point in the parking lot of the Pender County Public Library in Burgaw.

14. Other Notes, Issues or Additional Remarks: Pursuant to EO 117 issued March 14, 2020, all persons are urged to maintain social distancing (approximately six feet away from other people) whenever possible and to continue to wash hands, utilize hand sanitizer and practice proper respiratory etiquette (including coughing into elbow).
