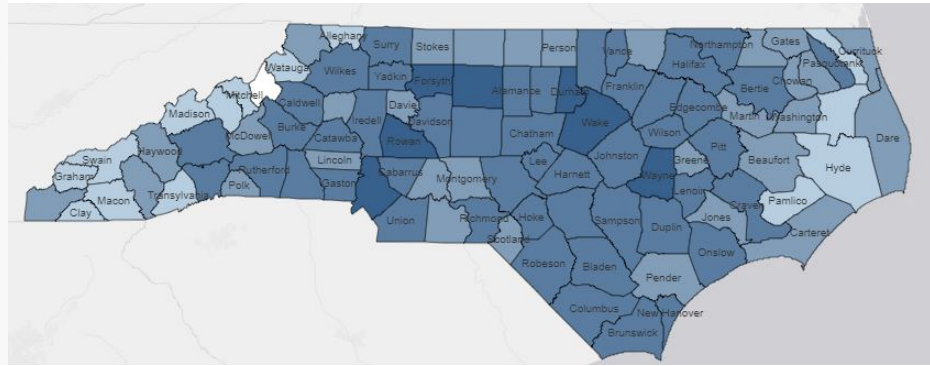
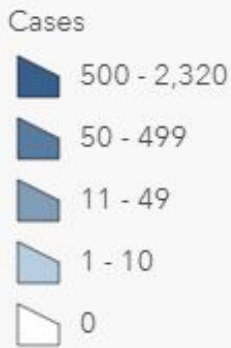




**Pender County Situation Report #64 - COVID-19 Event
May 14, 2020 - The County is operating at EOC Status Level 3.**

<p>7. Current Situation: EOC IS OPERATING AT A LEVEL 3 STATUS. Level 3 is a hazard specific response to an incident. This incident requires the assistance of several State agencies. The Emergency Operations Center is activated but only staffed with essential personnel. The EOC is not operating on 24-hour shifts. The EOC is only functioning during standard business hours, with minimal weekend staffing.</p> <p>Weather: Today: Mostly sunny, with a high near 79. South wind around 8 mph, with gusts as high as 16 mph. Tonight: Mostly clear, with a low around 58. South wind 5 to 9 mph, with gusts as high as 16 mph. Tomorrow: Sunny, with a high near 81. South wind 3 to 8 mph. Enhanced rip currents are possible at the beaches Friday evening into Monday.</p> <p>Fire Weather: RP-3: A warming trend and dry weather will continue through the weekend. As high pressure off the Carolina coast continues to shift eastward the humidities will increase. Low pressure developing in the northern Bahamas may become a subtropical cyclone this weekend as it moves generally northward between Bermuda and the Carolinas. No direct impacts on our weather are anticipated. A cold front will sweep offshore late Monday with a risk of scattered showers and storms. Wind profile analysis/fire control over flat terrain is Favorable. Fog potential for tonight is None.</p> <p>GOVERNOR COOPER EXECUTIVE ORDERS (EOs)</p> <ul style="list-style-type: none"> EOs 117, 118, 119, 120, 121, 122, 124, 125, 129, 130, 131, 133, and 134 remain in effect except as superseded by subsequent orders. Details here. EO 135 (April 23, 2020): Extended stay at home order and orders limiting mass gatherings, requiring social distancing, and restricting visitation at long term care facilities. EO 136 (April 24, 2020): Authorized and encouraged remote nonprofit corporation member and board meetings during the COVID-19 State of Emergency. EO 138 (May 5, 2020): Eased restrictions on travel, business operations, and mass gatherings (“Phase 1”) beginning May 8, 2020 at 5:00 PM. EO 139 (May 12, 2020): Provided additional regulatory flexibility to meet North Carolina’s health and human services needs At a press conference on 4/24, Gov. Cooper announced that remote learning will continue for the remainder of the 2019-2020 academic year. <p>The public can subscribe to text updates from NC DHHS regarding COVID-19 by texting COVIDNC to 898211. 9. Incident Area: As of today (5/14), the Pender County Health Department is aware of a total of forty-two (42) Pender County residents who have tested positive for COVID-19. Of the positive cases, nineteen (19) are offenders at Pender Correctional, twenty-two (22) are in the community, and one (1) is out of state. Fifteen (15) of the individuals who tested positive have recovered, while one (1) is deceased.

NC DHHS is reporting forty-three (43) cases in Pender County, however this is believed to be a data entry error.

The Pender County Health Department is aware of **three hundred and forty-two (342)** residents of Pender County tested for COVID-19 by healthcare providers within the county. Of those tests, twenty-four (24) were confirmed positive, **two hundred and ninety-four (294)** were confirmed negative, while **twenty-four (24)** tests are currently pending. There have been eighteen (18) additional confirmed positive tests of Pender County residents performed by healthcare providers outside the county.

NC DHHS is now providing a map of COVID-19 cases by ZIP code, [available here](#). To respect patient privacy and comply with federal law, more specific information about these cases is not available. Every surrounding county has confirmed cases of COVID-19, so all Pender County residents should assume they are capable of getting or spreading the virus and take recommended precautions accordingly.

10. External Affairs: Pender County remains in monitoring mode. The Public Information Officer and the communications team are monitoring the County’s social media platforms and updating the County’s website with accurate information.

11. County Action:

- Pender County School System is feeding students and anyone 18 or younger at 56 sites, details [available here](#).
- Pender County Schools is providing wi-fi hotspots for school-issued devices from 7 AM to 7 PM seven days a week at Pender High, Topsail High, Heide Trask High, West Pender Middle, and Penderlea School. There is also a public wi-fi access point in the parking lot of the Pender County Public Library in Burgaw.
- Pender County Government is strongly encouraging appointments for in-person visits, information [available here](#). In accordance with the governor’s order that teleworking be practiced to the maximum extent possible, many staff members began teleworking starting Tuesday, March 31. All teleworking staff are to report back to work on Tuesday, May 19th in preparation for re-opening.
- Pender County Board of Commissioners Chairman George Brown declared a State of Emergency effective Monday, March 30, 2020.

12. Other Notes, Issues or Additional Remarks: Pursuant to EO 117 issued March 14, 2020, all persons are urged to maintain social distancing (approximately six feet away from other people) whenever possible and to continue to wash hands, utilize hand sanitizer and practice proper respiratory etiquette (including coughing into elbow).

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) **especially** in areas of significant community-based transmission.
