

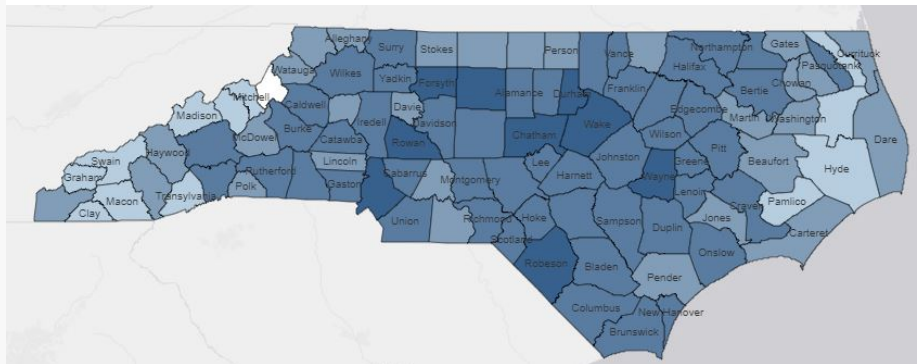
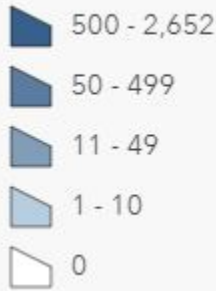


**Pender County Situation Report #68 - COVID-19 Event
May 18, 2020 - The County is operating at EOC Status Level 3.**

<p>7. Current Situation: EOC IS OPERATING AT A LEVEL 3 STATUS. Level 3 is a hazard specific response to an incident. This incident requires the assistance of several State agencies. The Emergency Operations Center is activated but only staffed with essential personnel. The EOC is not operating on 24-hour shifts. The EOC is only functioning during standard business hours, with minimal weekend staffing.</p> <p>Weather: Today: Mostly cloudy, with a high near 81. Northwest wind around 10 mph, with gusts as high as 17 mph. Tonight: A chance of showers and thunderstorms, then showers likely and possibly a thunderstorm after 2am. Mostly cloudy, with a low around 66. East wind around 6 mph. Chance of precipitation is 60%. New rainfall amounts between a tenth and quarter of an inch, except higher amounts possible in thunderstorms. Tomorrow: Showers likely and possibly a thunderstorm before 1pm, then showers and thunderstorms likely after 1pm. Cloudy, with a high near 77. East wind 7 to 10 mph, with gusts as high as 18 mph. Chance of precipitation is 70%. New rainfall amounts between a half and three quarters of an inch possible. A high rip current risk is in effect until 8 PM this evening, and there is an elevated risk of rip currents Tuesday and Wednesday. Heavy Rainfall Tuesday and Wednesday may result in temporary localized flooding.</p> <p>Fire Weather: RP-1: A brief dry period is likely this morning through afternoon before unsettled weather returns this evening. There is the possibility of heavy rainfall through Wednesday. A gradual improvement is likely by late week with drier conditions expected for the weekend. Wind profile analysis/fire control over flat terrain is Favorable. Fog potential for tonight is None.</p> <p>GOVERNOR COOPER EXECUTIVE ORDERS (EOs)</p> <ul style="list-style-type: none"> EOs 117, 118, 119, 120, 121, 122, 124, 125, 129, 130, 131, 133, and 134 remain in effect except as superseded by subsequent orders. Details here. EO 135 (April 23, 2020): Extended stay at home order and orders limiting mass gatherings, requiring social distancing, and restricting visitation at long term care facilities. EO 136 (April 24, 2020): Authorized and encouraged remote nonprofit corporation member and board meetings during the COVID-19 State of Emergency. EO 138 (May 5, 2020): Eased restrictions on travel, business operations, and mass gatherings (“Phase 1”) beginning May 8, 2020 at 5:00 PM. EO 139 (May 12, 2020): Provided additional regulatory flexibility to meet North Carolina’s health and human services needs At a press conference on 4/24, Gov. 9. Incident Area: As of today (5/18), the Pender County Health Department is aware of a total of **fifty (50)** Pender County residents who have tested positive for COVID-19. Of the positive cases, nineteen (19) are offenders at Pender Correctional, **thirty (30)** are in the community, and one (1) is out of state. Eighteen (18) of the individuals who tested positive have recovered, while one (1) is deceased.

The Pender County Health Department is aware of **three hundred and ninety-two (392)** residents of Pender County tested for COVID-19 by healthcare providers within the county. Of those tests, **twenty-nine (29)** were confirmed positive, **three hundred and forty-one (341)** were confirmed negative, while **twenty-two (22)** tests are currently pending. There have been **twenty-one (21)** additional confirmed positive tests of Pender County residents performed by healthcare providers outside the county.

To respect patient privacy and comply with federal law, more specific information about these cases is not available. Every surrounding county has confirmed cases of COVID-19, so all Pender County residents should assume they are capable of getting or spreading the virus and take recommended precautions accordingly.

10. External Affairs: Pender County remains in monitoring mode. The Public Information Officer and the communications team are monitoring the County’s social media platforms and updating the County’s website with accurate information.

11. County Action:

- Pender County School System is feeding students and anyone 18 or younger at 56 sites, details [available here](#).
- Pender County Schools is providing wi-fi hotspots for school-issued devices from 7 AM to 7 PM seven days a week at Pender High, Topsail High, Heide Trask High, West Pender Middle, and Penderlea School. There is also a public wi-fi access point in the parking lot of the Pender County Public Library in Burgaw.
- Pender County Government is strongly encouraging appointments for in-person visits, information [available here](#). In accordance with the governor’s order that teleworking be practiced to the maximum extent possible, many staff members began teleworking starting Tuesday, March 31. All teleworking staff are to report back to work on **Friday, May 22nd** in preparation for re-opening.
- Pender County Board of Commissioners Chairman George Brown declared a State of Emergency effective Monday, March 30, 2020.

12. Other Notes, Issues or Additional Remarks: Pursuant to EO 117 issued March 14, 2020, all persons are urged to maintain social distancing (approximately six feet away from other people) whenever possible and to continue to wash hands, utilize hand sanitizer and practice proper respiratory etiquette (including coughing into elbow).

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) **especially** in areas of significant community-based transmission.
